



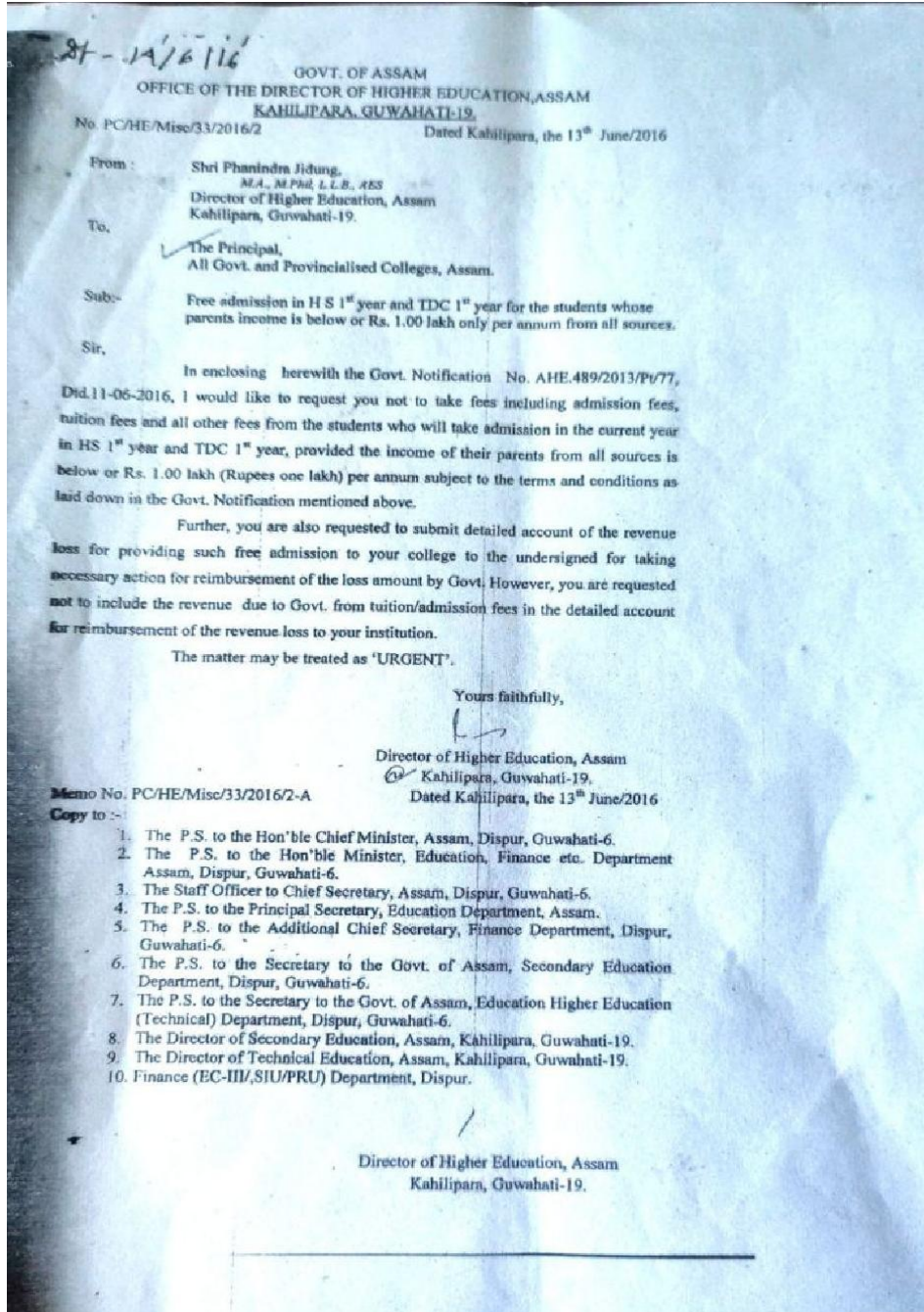

**ORDERS BY THE GOVERNOR
NOTIFICATION**

Dated Dispur, the 11th June/2016

ORDER No. AHE/2013/Pt./77 : Government of Assam in the Higher Education Department has decided that henceforth no provincialized and government colleges of Assam will take fees for admission fees, tuition fees and all other fees from the students who will take admission in the current year in HS 1st year and TDC 1st year provided income of their parents is below or equal to Rs. 1,00,000 (Rupees one lakh) only per annum from all sources, subject to the following terms and conditions:

- The Principals will take certificate regarding income of parents as follows :-
 - If the parents work either in State or Central Government then their monthly salary slip will have to be produced while taking admission in colleges.
 - If they are working in private organization then the salary slip from employer indicating that their salary is not above Rs. 1.00 lakh (Rupees one lakh) only.
 - If they are not working either in Government or in any private institution or organization then the certificate from the Circle Officer or Mouzadar will be considered.
 - In addition to the above three conditions, if the principal and the admission committee in their wisdom feel that the income of a particular student or students is below Rs. 1.00 lakh (Rupees one lakh) only, then also concerned Principal can give free admission to these students.
- After the admission procedure is over, the concerned college will give a detailed accounts of the revenue loss to the DHE for reimbursement.
- After that, DHE will compile college-wise compensation and put up the proposal to the Government for reimbursement. The reimbursement will be complete within two months from the submission of statement by the colleges.
- While calculating the compensation, the revenue due to the Government from tuition/ admission fees will not be included.

ii. A declaration from the students that neither of the parents (father or mother) of the student is an employee of State/Central Govt. Department or its undertaking. Such form shall be devised by the concerned Registrars/Principals. If such a declaration is found to be false, the admission shall be cancelled and fee shall be realized from such students.

6. Power of Admission Committees: The Admission Committees of the concerned Colleges and Universities shall have the power to enquire into the income of the family in case of doubt in regard to students and if the committee is of the view that the income of the parents exceeds Rs. 2.00 Lakh, the Committee may recommend cancellation of admission notwithstanding documents submitted by the student. Such enquiry may commence suo moto by the institute or on a complaint received against any student availing benefit under this scheme. The Category of Institutes coming under the purview of the Scheme, shall constitute such committees comprising of Senior Teachers. The Principal/ Registrar of the institution shall observe due diligence and will not allow any undeserving candidates. The Director of Higher Education will make random check of income certificate and disciplinary action may be taken against the student/ official or principal.

Colleges will realize only Magazine fees, Games & Sports fees and College Week Fees. All other fees will be exempted. This benefit will accrue to those students who were admitted under this scheme during 2016-17, 2017-18 and 2018-19 session
Final year admission:	M.A./M.Sc./M.Com. for the session 2019-20 for those admitted with no fee during the session 2018-19	

8. Duties and Responsibilities of Students availing the Scheme :

Students seeking admission into 1st year will plant a sapling at his/her College or at his/her home and shall give photograph of the same to the college, The student has to nurse the sapling and while seeking admission into second year shall give photograph of the same tree that was planted during previous year. A Scrutiny Committee shall be constituted comprising teachers from Biology background who shall examine the photographs and will assess the genuineness of the Photographs and growth of the plant. If the College does not have science stream, teachers from nearby colleges will be deputed for such purpose by the Director of Higher Education. Only on receipt of recommendation from the Committee, the student can avail subsequent year fee waiver. This will be effective from the session 2019 (applicable to those who benefitted under the scheme during 2016-17 and 2017-18 session). Students availing the fee waiver benefit during the Current Year shall submit photograph of the sapling planted by them earlier to the College authority and the college authority shall scrutinize the authenticity of the same and allow the candidate accordingly.

OFFICE MEMORANDUM

Considering the situation arising out of COVID 19, the Government of Assam is pleased to waive all fees relating to admission and all other categories including examinations, festivals, publication, excursions, fees for laboratories, students union fees, college weeks, magazine fees, games & sports fees, cost of prospectus, registration fees etc. for the academic session 2020-21 irrespective of the income or the economic status of their parents.

The benefit of fee waiver will cover State Universities, Govt. Colleges, Provincialised Colleges under Directorate of Higher Education, Assam and all institutions under Directorate of Technical Education, Assam including Engineering Colleges and Polytechnic Institutes.

However, fee waiver will not include Self-financing Courses of the Colleges/Institutes and hostel admission fees. Further, hostel admission fee should not be increased during the current year. Also hostel mess dues should not be part of the fee waiver scheme.

The entire fees which will be waived, will be reimbursed by the Govt. within 30 (thirty) days from the date of receipt of the claims from the respective Colleges/Institutes. The Universities and Colleges shall project claims in terms of the uniform fees structures as notified vide No. AHE 347/2-18/12 dtd. 01.06.2019.

The Director of Higher Education, Assam and the Director of Technical Education will not wait for the demand to be received from all institutes. Even if demand is received from a single institute, the proposal will be processed for re-imbursement.

The above scheme will be applicable to the students domicile from Assam only.


